

Existing browser automations that do not use insert/invoke JavaScript capabilities will not be impacted. Following the adoption of MV3 browser extensions, in order to use the JavaScript insert/invoke capabilities, the appropriate web drivers need to be installed. Version 10.3 of the Email – POP3/SMTP/IMAP VBO is currently incompatible with Blue Prism Cloud

Blue Prism Cloud customers who use the Email - POP3/SMTP VBO should not update the VBO to version 10.3 until further notice. Version 10.2.1 and earlier of the VBO continue to function without issue following an upgrade to Blue Prism Enterprise 7.3 on Blue Prism Cloud.

This is a change from the originally intended version of Blue Prism 7.1 due to the current known issues for this version, therefore an alternative earlier version is supplied. Blue Prism 7.x will be made available in a future release of Blue Prism Cloud.
